

Itinerary*

Thursday, July 10, 2014 - USA to St. Petersburg, Russia

Depart USA via overnight trans-Atlantic flights on scheduled airline to St. Petersburg, Russia.

Friday, July 11, 2014 - St. Petersburg

Upon late afternoon arrival in St. Petersburg transfer via taxi (own cost) to the hotel. Meet your Multi-Lingual Escort who will remain with you the entire tour. Enjoy a Welcome dinner tonight hosted by your escort. Overnight in St. Petersburg. (D)

Saturday, July 12, 2014 - St. Petersburg

Meet a local guide and enjoy a guided city tour of St. Petersburg. Drive along Nevsky Prospect, see the Church of Our Savior On Spilled Blood and explore Palace Square. Your tour will end with a visit to St Isaac's Cathedral. Time for lunch on own. In the afternoon visit the Peter & Paul Fortress. The cathedral, although plain on the outside, has a magnificent baroque interior. Continue to the Cabin of Peter the Great, the first house built in Peter's city. Dinner on your own and overnight in St. Petersburg. *(CB)*

Possible 1st performance: Lutheran Church of St. Peter and St. Paul on Nevsky Prospekt, one of the largest Protestant Churches in Russia or St Mary Catholic Church

Sunday, July 13, 2014 - St. Petersburg

In the morning you will enjoy a guided visit of the world famous State Hermitage Art Museum. The museum occupies six magnificent buildings situated along the embankment of the River Neva, right in the heart of St. Petersburg. After lunch on own in museum board the hydrofoil boat, which will take you in about 45 minutes, to the Peterhof Palace and gardens for a visit. Bus will take you back to your hotel in St Petersburg for dinner on own and overnight. *(CB)*

Optional: Attend local choral concert (pending announcement of local concert schedule).

Monday, July 14, 2014 - St. Petersburg

Leave the city and drive south for a guided tour of Catherine's Palace. The summer residence for the wife of Peter the Great, Catherine I. In the afternoon enjoy a visit of the historical Summer garden on your way back to St. Petersburg. Dinner on your own and overnight St. Petersburg. *(CB)*

Possible 2nd performance: Lutheran Church of St. Peter and St. Paul on Nevsky Prospekt, one of the largest Protestant Churches in Russia or St Mary Catholic Church

Tuesday, July 15, 2014 - St. Petersburg to Tallinn, Estonia

Breakfast at the hotel and check-out. Board motor coach for a day traveling along the south side of the Gulf of Finland in the Baltic Sea as you transfer to Tallinn, Estonia for 2 nights. Estonia is the most northerly of the three Baltic States and the most Scandinavian. Tallinn is a lovely medieval old town and the hub of Estonian life. The Old town of Tallinn is in the list of Unesco World Heritage sites. Enjoy a group dinner at a local restaurant this evening and overnight in Tallinn. *(CB, D)*

Wednesday, July 16, 2014 - Tallinn

Take a guided tour of the Estonian Capital city. See the twin towers of the Viru Gate, Town Hall Square, and the Alexander Nevsky Cathedral. At the end of tour, visit Toompea Castle. It is the seat of the Parliament of the Republic of Estonia. Group dinner and overnight in Tallinn. (CB, D)

Evening Performance 3: Possible connection with Allan Vurma, University of Tallinn (friend of Allan Petker)

Alternatively: possible late afternoon performance in the PÜHMA VAIMU CHURCH (Holy Spirit Church)

Thursday, July 17, 2014 - Ferry - Tallinn to Stockholm

Breakfast at the hotel. Morning free time to explore on your own. This afternoon depart by ferry to Stockholm. Dinner on your own on the ferry and overnight. (CB)

Friday, July 18, 2014 - Stockholm

After breakfast on the ferry, arrive in Stockholm, the Royal Capital of Sweden. Discover a city like no other - a city built on 14 islands, where you are never far from the water. Well-preserved medieval buildings stand alongside modern architecture. Before checking into your hotel enjoy a guided tour of the city. Experience the medieval atmosphere of the Old Town "Gamla Stan," the Kungliga Slottet, Riddarhuset - The House of Nobility and the Storkyrkan (Stockholm Cathedral). Dinner on your own and overnight in Stockholm. (CB)

4th concert in one of the following venues:

Santa Clara Kyrka, Tyska Kyrkan/St Gertrudes church right in the heart of the old city Gamla Stan or Hedvig Eleonora Church in central Stockholm

Saturday, July 19, 2014 - Stockholm

Breakfast at the hotel then visit the World Class Vasa Museum. When the Vasa set sail in 1628, she was probably the world's most powerful warship, but she sank on her maiden voyage. This grand warship is almost wholly preserved, and is the only one of its type in the world. Enjoy free time the rest of the afternoon to do some last minute souvenir shopping or visit Skansen, the oldest open air museum in the world, City Hall (where Nobel Prizes are awarded) or the Royal Palace. Dinner on own. Overnight in Stockholm. (CB)

Sunday, July 20, 2014 - Stockholm

Breakfast at the hotel. Day at leisure on your own. Festive Farewell Dinner tonight and overnight in Stockholm. (CB, D)

Monday, July 21, 2014 - Departure Stockholm to USA

Transfer to the airport via taxi (own cost) for return trans-Atlantic flight to USA.

PAYMENT TERMS: In order to meet deposit schedules with suppliers for this tour, Corporate Travel Service asks for prompt payment on the requested dates. Please see the reservation form for the payment schedule. Corporate Travel also accepts Visa and MasterCard for payment. Traveler agrees not to dispute any credit card charges associated with this trip.

CANCELLATION POLICY: A notice of cancellation must be received in writing. Forfeit \$100 for cancellations between time of deposit and February 10, 2014. Forfeit \$350 for cancellations between February 10, 2014 and April 1, 2014. Forfeit \$1,600 for cancellation between April 1, 2014 and May 11, 2014. After May 11, 2014, there will be no refund. PASSPORT: A valid U.S. Passport is required of all passengers. Please apply for your passport immediately as passports may take a long time to process. Please provide Corporate Travel with a copy of the inside page of your passport (showing your name and photo) at the time of reservation.**

VISA: Visa is required to visit Russia. Do not obtain the visa until notified in writing that there are enough participants registered to operate this tour. Obtaining a Russian Visa can be complicated, so it is recommended to use a professional visa agency to assist with the "red-tape." Cost is about \$300 inclusive of service charges. "Russian Universal Services" is located in Los Angeles and may be contacted at www.rusonline.com. "Russian Connections" is located in San Francisco and may be contacted at gettorussia.com.

AIRFARE: Trans-Atlantic airfare to St. Petersburg, Russia and back from Stockholm, Sweden is not included in the price. This trip is offered land only. DO NOT purchase Trans-Atlantic airfare until notified in writing that there are enough participants registered to operate this tour. Corporate Travel's retail agency will be happy to assist in arranging your flights. Call (313) 565-8888 ext. 121

AIRPORT TRANSFERS: Not included. Transfer via taxi on your own cost on arrival in St. Petersburg and on return from Stockholm.

TRAVEL DOCUMENTS: Unless otherwise notified, Corporate Travel will mail to you or your group leader a more detailed itinerary and General Information Sheet approximately 2 weeks or 10 days before departure.

ITINERARY: The Itinerary as presented in this brochure is tentative and represents what we are planning for you, however it is subject to confirmations from many organizations. Because of changes in local schedules, we may need to alter specified events, dates and/or venues to better fit the overall plan. The right is reserved to alter or cancel the itinerary, at Corporate Travel Service's sole discretion, as it may deem necessary or advisable.

GRATUITIES: Gratuities for your escort, driver and guides are not included. It is customary to tip the escort \$5.00 and the driver \$3.00 per person per day. The tip for the local guides is usually about one \$2.00 for half-day tours and \$3.00 for full day tours

ROOMS: Tour prices are per person according to a room type: a "Single" room is one person in a room and a "Double" is two persons in one room. "Triple" rooms are

discouraged because of cramped quarters. Triples are one double bed with two persons sharing the bed and one single bed. Triples are not always available and are discouraged because of cramped quarters.

LUGGAGE: Baggage is at owner's risk throughout the tour.

Checked Baggage: Fees are not included in this tour package price. Most airlines charge fees ranging from free to \$75 per bag one way. If traveling with group air, the air carrier for your flight will be announced in your final travel documents and an online link provided to learn the exact charges of your carrier. (Note:The website iflybags.com may be helpful and gives sample fees for all carriers.) Checked baggage is limited to one bag per person. There can be no exceptions. For most airlines, the one checked bag is limited to 50 pounds and 62 inches (length + width + height). If these specifications are exceeded, excess charges may be collected by the airline at the airport. Do not lock baggage you intend to check in at the airport. Please confirm these specifications when you receive your final travel documents, as they can and do change.

<u>Carry On Luggage:</u> You may also bring a small carry-on bag that will fit under an airline seat and on the small parcel racks of the motor coach, which average about 8 inches high by 18 inches deep. It is best if your carry-on bag is soft sided, as the parcel racks on the motor coaches are small. Currently, travelers are allowed to transport only small amounts of liquids, gels, lotions, aerosols or similar items on their person or in their carry-on luggage. Details will be in your final travel documents.

HEALTH REQUIREMENTS: Travelers must be medically and physically fit for this tour. This tour requires significant walking, as motor coaches are not permitted to pick up and drop off in front of major attractions. The tour is not wheelchair accessible. Any special medical conditions or equipment must be advised in writing, for evaluation of feasibility, at the time of making your reservation. Should any special assistance be required, traveler agrees to bring a companion capable and willing to assist traveler.

CHILDREN UNDER 18: Reduction of rates are possible for infants/children -Contact Corporate Travel for more information.
