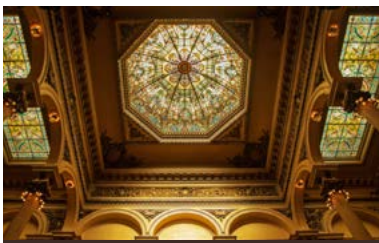

PERFORMANCE TOUR TO ARGENTINA

ITINERARY*

Day 1 - Depart USA

Day 2 - Arrive in Córdoba, Argentina. Córdoba, once one of the most important cities in South America, was founded in 1573 as a major crossroads on the missionary and trade routes connecting the Spanish colonies across the continent. Hotel Check-in. Welcome dinner. Overnight Córdoba.

Day 3 - Half-day guided tour of Córdoba. Visit locations such as Manzana Jesuita (Jesuit Square) and Plaza San Martín, where the Iglesia Catedral (the most important church in the city) sits in the heart of Córdoba. Afternoon rehearsal. Stroll down Obispo Trejo, a pedestrian shopping promenade lined with local shops and cafés, or stop by the Paseo de Artes to shop for crafts and food from local artisans. Dinner on own. **This evening, perform a concert in Córdoba.** Overnight Córdoba.

Day 4 - Morning at leisure. Depart mid-day for Rosario, which is approximately a 3-4 hour drive. With a population of approximately 1 million people, Rosario is tied with Córdoba as Argentina's second-largest city. Rosario has a vibrant economy and active arts and culture community. Hotel check in, dinner included. Overnight Rosario.

Day 5 - Half-day guided tour of Rosario. Visit sites such as the city's main square, Plaza 25 de Mayo, and the patriotic Monumento á la Bandera, a 200-foot high tower of unpolished marble. Afternoon at leisure for time by the river, Río Paraná. Dinner on own. **Evening Concert in Rosario.** Overnight Rosario.

Day 6 - Depart Rosario for the Buenos Aires domestic airport. Flight to Iguazú. Iguazú Falls, located in the Iguazú National Park, features 250 waterfalls, from smaller less-spectacular falls to the thundering horseshoe-shaped Garganta del Diablo (Devil's Throat). Iguazú's waterfalls extend for nearly two miles across a lush sub-tropical rainforest setting. Check into hotel. Dinner on own. **Concert in Iguazu.** Overnight Iguazu.

Day 7 - Full-day guided tour of Iguazu Falls, Argentina. Trails, bridges, and catwalks take you through the rainforest along the tops of the falls for breathtaking views. There are six distinct viewpoints along Paseo Superior, including some of the most impressive cascades, such as the Dos Hermanas, Chico and Mendez falls. The highlight of your tour will be the massive Garganta del Diablo Falls. Lunch on own during the tour; dinner included. Overnight Iguazu.

Day 8 - Transfer to Posadas, with stops at the Wanda Mines, a gem mine famous for producing amethyst, and the Ruins of St. Ignacio, one of the many missions founded by the Jesuits in the Paraguay region and an UNESCO World Heritage Site. Arrive in Posadas, once a port of great economic importance along the Río Paraná, and now a vibrant city connecting Argentina and Paraguay. Check into the hotel. Dinner on own. **Concert in Posadas.** Overnight Posadas.

Day 9 - Depart for Buenos Aires from either the Posadas or Iguazu airport, depending on flight availability. Upon arrival in Buenos Aires, as time allows, take a panoramic motorcoach tour of the city. Buenos Aires, the cultural, political, and economic heart of Argentina, is a world-class city of 10 million people. The sophistication of this city is reminiscent of European capitals, such as Paris, Rome, or Madrid. Buenos Aires has a rich musical life and tradition, and is most famous for the Tango. Check into the hotel. Dinner included. Overnight Buenos Aires.

Day 10 - Half-day guided tour of Buenos Aires, including the main sights in the Center, San Telmo, La Boca, and Puerto Madero. Afternoon entrance to Eva Perón, Museum. Eva Perón, the former first lady of Argentina, was beloved by Argentinians for her charity work and her efforts for women's suffrage. Dinner on own. **Concert in Buenos Aires.** Overnight Buenos Aires.

Day 11 - Morning tour of Teatro Colón, one of the world's most important opera houses and a cultural treasure of Buenos Aires. The Colón was completed in 1908 to fulfill the ambitions of Buenos Aires' elite families to emulate the style of the finest cities of Europe. The theater's magnificent performance hall, La Sala, seats 2,478 and has hosted some of the world's most prominent performing groups. Afternoon visit of MALBA Art Gallery (Latin American Art Museum of Buenos Aires) featuring works by contemporary Latin American artists. Overnight Buenos Aires.

Day 12 - Depart this morning for an exciting day trip to an authentic Argentinian estancia (cattle ranch). Experience the life of the gauchos (cowboys) and learn about their rich history. Then, enjoy an authentic Argentinian asado (barbecue) for lunch while the gauchos perform local folklore dance and tango. After lunch, watch the gauchos perform on horseback before returning to Buenos Aires. Dinner on own. Overnight Buenos Aires.

Day 13 - Full day at leisure for independent exploration of Buenos Aires. Evening Tango Show with dance lesson and dinner in one of Buenos Aires' authentic dinner theatres. Dine on traditional Argentinian specialties as you are entertained by sleek Tango dancers performing the traditional dance with its distinctive and dramatic movements. Overnight Buenos Aires.

Day 14 - Check out of the hotel and enjoy a day at leisure and some last minute shopping on Calle Florida, the pedestrian shopping street in the heart of Buenos Aires featuring high-quality leather goods. Depart for the USA (flights often depart late at night).

Day 15 - Overnight flights arrive in the USA.

CANCELLATION POLICY: All cancellations must be received in writing. Forfeit \$500 for cancellations between time of deposit and 6/14/16. Forfeit \$1,750 for cancellations between 6/15/16 and 9/14/16. After 9/14/16, there will be no refund. Penalties will be according to the fax or postmark date.

TRAVEL DOCUMENTS: Unless otherwise notified, CTS will mail you your travel information approximately 10-14 days before departure.

Because of changes in local schedules, we may need to alter specified events, dates and/or venues to better fit the overall plan. The right is reserved to alter or cancel the itinerary, at CTS's sole discretion, as it may deem necessary or advisable.

GRATUITIES: Gratuities for your escort, driver and guides are included.

ROOMS: Tour prices are per person according to a room type: a "Single" room is one person in a room and a "Double" is two persons in one room. Triples are one double bed with two persons sharing the bed and one single bed. Triples are not always available and are discouraged because of cramped quarters and smaller beds.

LUGGAGE: Baggage is at owner's risk throughout the tour.

Checked Baggage: Fees are not included in this tour package price. Most airlines charge fees ranging from free to \$100 per bag one way. If traveling with group air, the air carrier for your flight will be announced in your final travel documents and an online link provided to learn the exact charges of your carrier. (Note: The website iflybags.com may be helpful and gives sample fees for all carriers.) Checked baggage is limited to **one** bag per person. There can be no exceptions. For most airlines, the one checked bag is limited to **50 pounds and 62 inches** (length + width + height). If these specifications are exceeded, excess charges may be collected by the airline at the airport. Do not lock baggage you intend to check in at the airport. Please confirm these specifications when you receive your final travel documents, as they can and do change.

Carry On Luggage: You may also bring a small carry-on bag that will fit under an airline seat and on the small parcel racks of the motor coach, which average about 8 inches high by 18 inches deep. It is best if your carry-on bag is soft sided, as the parcel racks on the motor coaches are small. Currently, travelers are allowed to transport only small amounts of liquids, gels, lotions, aerosols or similar items on their person or in their carry-on luggage. Details will be in your final travel documents.

Hazardous Materials: Federal law forbids the carriage of hazardous materials aboard the aircraft, in your luggage, or on your person. A violation can result in five years imprisonment and penalties of \$250,000 USD or more (49 U.S.C. 5124). Hazardous materials include explosives, compressed gases, flammable liquids and solids, oxidizers, poisons, corrosives, and radioactive materials.

HEALTH REQUIREMENTS: Travelers must be medically and physically fit for this tour. This tour requires significant walking, as motor coaches are not permitted to pick up and drop off in front of major attractions. The tour is not wheelchair accessible and is not suitable for motorized scooters, walkers, and canes. Any special medical conditions or equipment must be advised in writing, for evaluation of feasibility, at the time of making your reservation. Should any special assistance be required, traveler agrees to bring a companion capable and willing to assist traveler.

CHILDREN UNDER 18: For a minor under the age of 18 to travel out of the United States without both parents or legal guardians, a notarized affidavit from the non-travelling parent(s) or guardian(s) must be obtained and presented upon departure and return to the United States. You may request a form from our office.

STATE DEPARTMENT & OTHER AGENCIES: From time to time the State Department (www.state.gov) and the Center for Disease Control (www.cdc.gov) and other government agencies and departments issue travel advisories or warnings for one or more of the destinations that you may be visiting on tour. All cancellation penalties remain in full force and effect.

PHOTOGRAPHY: CTS may take photographs or film of its trips and trip participants, and participant grants CTS express permission to do so and for CTS to use such for promotional or commercial use without payment of any fee or royalties.

UNUSED SERVICES: There is no right to a refund for any unused services including airline tickets.
